

What is SIR:

SIR stands for social Intensive Revision: SIR is the way to amend the State's Electoral Rolls. SIR is a unique voter list verification process in India. It is important for ensuring accurate, Fraud-Free Elections through comprehensive voter validation.

Purpose of it:

SIR has been done for revision of Electoral Roll. It means to add the new voters in the list and to delete the name of voters due to death, migration to another constituency and deletion of multiple entry of the same person.

Last SIR:

Coincidentally the last SIR was held in 2003 at the time of NDA government led by BJP when Late Shri Atal Bihari Vajpayee ji was the Prime Minister of the nation.

Why SIR is going on:

The present BJP led NDA government is saying that the SIR is being held to revise the voter list/electoral roll and to stop the fake voters and multiplicity of votes by a single person. Whereas on seeing it, it appears to be something else.

By SIR model of Bihar it looks like that BJP wants to cut the votes of Muslims and to add the voters who vote for them and to add the

voters who vote for them. Another thing which is appearing from this SIR is that there is discrepancy in the final list of voters published on 30 Sep 2025 as total votes 7.42 while total voters participation shows 7,45,26,858 in Bihar Election 2025 on behalf of data published by the Election Commission after the Election of Bihar.

Bihar records highest female voter turnout in its history

1. Bihar Legislative Assembly elections concluded with a historic highest ever voter turnout of **66.91%** This is the highest voter turnout recorded in the State since 1951. Turnout among male voters is **62.8%** and amongst female voters it is **71.6%**. Details in Annexures 1 & 2.

3. CEC Shri Gyanesh Kumar along with ECs Dr. Sukhbir Singh Sandhu and Dr. Vivek Joshi monitored the conduct of the elections from the Control Centre in ECI through Webcasting facility provided across all **45,399 Polling Stations in Phase-II as well.**
4. Over the two phased elections in Bihar, **more than 8.5 Lakh Polling related Staff, over 1.4 lakh Polling Agents** appointed by **2,616 contesting candidates, 243 General Observers, 38 Police Observers** and **67 Expenditure Observers** were part of the election machinery conducting and observing the elections.
5. For the first time, 16 delegates from 6 countries namely, South Africa, Indonesia, Thailand, the Philippines, Belgium and Colombia visited and witnessed the poll proceedings as part of the International Election Visitors' Programme (IEVP) this year. The delegates commended the Bihar elections for being internationally, one of the most well-organised, transparent, efficient and participative elections.

When I observe Closely then I can see 4 reasons for this:

1. To annoy people: As we all know that BJP failed in implementing its policies such as demonetisation, GST, CAA, NRC & lockdown which created only problems to the people.

2. SIR के पीछे का रहस्य:

जब मैं बारीकी से देखता हूँ तो मुझे इसके 4 कारण नजर आते हैं:

1. लोगों को परेशान करना: जैसा कि हम सभी जानते हैं कि बीजेपी लागू करने में विफल रही नोटबंदी, जीएसटी, सीएए, एनआरसी और लॉकडाउन जैसी इसकी नीतियों ने लोगों के लिए केवल समस्याएं पैदा कीं।

2. यह जाँचने के लिए कि कितने अंधभक्त हैं: जैसा कि हमने पहले देखा है कि भाजपा और पक्षपाती मीडिया (गोदी मीडिया) हमेशा अपनी विफलताओं को छिपाने और लोगों को वास्तविक मुद्दों जैसे बेरोजगारी, मुद्रास्फीति, मुद्रा दर, चीन के अतिक्रमण और देश की भूमि पर अवैध

अतिक्रमण, भारत की वैश्विक रैंकिंग आदि से दूर रखने के लिए प्रचार करते रहते हैं।

इसे देखने के बाद अल्लामा इकबाल साहब की एक शायरी याद आती है:

यह बेहतर है कि मुसलमानों को गैर-अभ्यास करने वाला बना दिया जाए और लोगों के दिमाग को वास्तविक इबादत (पूजा) से हटा दिया जाए जहां वे केवल लंबी प्रार्थनाएं करते हैं, न कि समाज में बुराइयों को चुनौती देने के लिए।

3. एनआरसी लागू करने के लिए:
